Position Summary

Relationships Australia Tasmania provides alternatives to formal legal processes for families who are separated, separating or in dispute to improve their relationships. Family Law Services have a particular role to help families with complex needs.

The role of the Counsellor in Family Law Services is primarily focussed on working with individuals, families and separated couples in response to any type of relationship breakdown, to improve the mental health and/or personal health and wellbeing of individuals. This service helps clients with relationship difficulties to better manage their personal and interpersonal relationship with children and family during or after separation.



Key Areas of Responsibility

- Engage with and assess clients and the impact of their situation on any children, including adult children.
- Provision of professional and appropriate counselling in the context of family separation.
- Provision of therapeutic services to individuals.
- To support individuals to manage the grief and loss associated with relationship breakdown.
- Provide and make referrals to other services for individuals as required.
- Completion of required administrative work associated with client sessions, including maintaining accurate client data and files and working within RA Tas' fee policy.
- Represent Relationships Australia Tasmania at meetings/events as required.
- Any other duties as required and within the general scope of responsibilities of this position.

Extent of Authority

The Counsellor informs and guides to gain the acceptance of others regarding the practices, systems and processes required to achieve program and service delivery outcomes. Selection Criteria

Essential Requirements (Skills, knowledge, experience, qualification(s) and/or training)

1. Degree in Social Work, Psychology or equivalent tertiary qualifications that are recognised to deliver therapeutic counselling services in accordance with agency requirements
2. Demonstrated experience in providing a broad range of counselling services
3. Knowledge and understanding of counselling theory and practice, family dynamics and the psychological development of relationships
4. Ability to communicate and engage with clients therapeutically and to assist clients with a broad range of intellectual abilities, motivational levels, and health profiles, and from a range of socio-economic backgrounds
5. Proven knowledge of mandatory reporting, suicide intervention and working with people who may be experiencing family violence
6. Ability to maintain professional independence whilst also participating in a small multi-disciplinary team
7. Capacity to reflect on own practice, with supervisor, peers and self
8. Ability to work within and positively advance the mission and values of Relationships Australia Tasmania

Desirable Attributes

9. Experience working with children and young people experiencing family separation
10. Current drivers' licence
11. Computer literacy
